# **II. DETAILED INFORMATION ABOUT THE FUNDING OPPORTUNITY**

# **II.A.** Program Description

The U.S. Army Medical Research Acquisition Activity (USAMRAA) is soliciting applications to the fiscal year 2024 (FY24) Neurofibromatosis Research Program (NFRP) using delegated authority provided by United States Code, Title 10, Section 4001 (10 USC 4001). The Congressionally Directed Medical Research Programs (CDMRP) at the U.S. Army Medical Research and Development Command (USAMRDC) is the program management agent for this funding opportunity. Congress initiated the NFRP in 1996 to provide support for research of high potential impact and exceptional scientific merit. Appropriations for the NFRP from FY96 through FY23 totaled \$427.85 million (M). The FY24 appropriation is \$25.0M.

The vision of the FY24 NFRP is to decrease the clinical impact of neurofibromatosis (NF). Toward this end, the NFRP promotes research directed toward the understanding, diagnosis, and treatment of NF1, NF2, and schwannomatosis to enhance the quality of life for persons with these disorders that impact Service Members, Veterans, and the general public.

# The proposed research must be relevant to active-duty Service Members, Veterans, military beneficiaries, and/or the American public.

#### II.A.1. NFRP Strategic Goals and FY24 Areas of Emphasis

The NFRP seeks to support innovative, high-impact research that will foster new directions for and address neglected issues in NF research; sponsor multidisciplinary and multi-institutional collaborations that will bring new perspectives to the field; promote translational and clinical studies to move promising ideas from bench to bedside; and develop a balanced portfolio of meritorious research related to all aspects of NF type 1 (NF1), NF type 2 (NF2), and schwannomatosis.

Strategic Goals: The NFRP's current strategic goals are:

- Foster basic and exploratory research.
- Facilitate rapid testing of potential therapeutics.
- Increase research capacity.
- Encourage research in areas of critical interest to NF patients.

Applicants are encouraged to review the NFRP's strategic plan for more information on its goals: <u>https://cdmrp.health.mil/nfrp/pdf/NFRP%20Strategic%20Plan.pdf</u>.

**Areas of Emphasis:** To meet the intent of the funding opportunity, all applications should specifically address the critical needs of the NF community in one or more of the Areas of Emphasis listed below. All applications are also encouraged to include materials and data from diverse populations in their research.

- NF2 and schwannomatosis-related areas (e.g., hearing, balance, schwannoma, ependymoma, meningioma, LZTR1, SMARCB1)
- Endpoint validation, biomarker discovery, and technological innovation for assessments
- Application of data science
- Non-tumor manifestations not limited to:
  - o Pain
  - Cognitive manifestations
  - o Sleep
- Heterogeneity of NF-related phenotypes
- Genetics, genomics, epigenetics, systems biology, metabolomics, or similar approaches
- Preclinical efficacy studies
- Target identification and drug discovery
- Nutritional, environmental, and other modifiers of NF
- Health services research

Note: Not all Areas of Emphasis are applicable to every award mechanism. If the proposed research project does not address at least one of the FY24 NFRP Areas of Emphasis, justification should be provided that it addresses an important problem related to NF research and/or patient care.

**Definition of Health Services Research:** Health services research studies the access, costs, and quality of health care for individuals, families, organizations, institutions, communities, and populations. It is a multidisciplinary field of scientific investigation, including basic and applied research, that examines how social factors, financing systems, organizational structures and functions, health technologies, and personal behaviors affect access to health care, the quality and cost of health care, and ultimately our health, well-being, and quantity and quality of life.

The goals are to identify the most effective ways to organize, manage, finance, and deliver highquality care, reduce medical errors, and improve patient safety. For more information, multiple resources are available including "Health Services Research: Scope and Significance," from the National Institutes of Health (NIH) publication *Patient Safety and Quality: An Evidence-Based Handbook for Nurses* found online at <u>https://www.ncbi.nlm.nih.gov/books/NBK2660/</u>. **NFRP Research Resources Initiative:** Resources developed through NFRP funding that are available to the scientific community can be found at

Investigators are urged to leverage and contribute to these resources and include a sharing and distribution plan in the application within the Data and Research Resources Sharing Plan (<u>Attachment 11</u>). For more guidance on data sharing, refer to the General Application Instructions, Appendix 2, Section K.

#### **II.A.2.** Award History

The NFRP New Investigator Award mechanism was first offered in FY. Since then, 421 New Investigator Award applications have been received, and 98 have been recommended for funding.

# **II.B.** Award Information

The intent of the NFRP New Investigator Award is to support the continued development of promising Early-Stage Investigators and/or the transition of Established Investigators from other research fields into a career in the field of NF research. Prior experience in NF research is not required. However, Principal Investigators (PIs) with a limited background in NF research are strongly encouraged to have a collaborator who is experienced in the NF field.

Participants will share data following the FAIR (Findable, Accessible, Interoperable, and Reusable) Data Principles for reproducible science found in "The FAIR Guiding Principles for scientific data management and stewardship (<u>https://www.nature.com/articles/sdata201618</u>). Refer to the Data and Research Resources Sharing Plan document in <u>Attachment 11</u>.

Research projects may focus on any phase of research, excluding clinical trials. *Applications must include preliminary and/or published data that may be outside of the NF field but must be relevant to NF and the proposed research project.* 

**Organizational Level Emphasis:** The following areas of emphasis are broadly applicable to many CDMRP programs, not just the NFRP. Investigators are encouraged to consider addressing these areas in their applications if doing so is appropriate for their line of research, addresses the FY24 NFRP strategic priorities and/ Areas of Emphasis described in Section II.A.1, and meets the intent of the award mechanism.

*Nuclear Medicine:* Innovative research involving nuclear medicine and related techniques to support early diagnosis, more effective treatment, and improved health outcomes of active-duty Service Members and their Families is encouraged. Such research could improve diagnostic and targeted treatment capabilities through noninvasive techniques and may drive the development of precision imaging and advanced targeted therapies.

*Women's Health:* The CDMRP encourages research on health areas and conditions that affect women uniquely, disproportionately, or differently from men, including studies analyzing sex as

a biological variable. Such research should relate anticipated project findings to improvements in women's health outcomes and/or advancing knowledge for women's health.

*Metastatic Cancer Task Force:* A congressionally mandated Metastatic Cancer Task Force was formed with the purpose of identifying ways to help accelerate clinical and translational research aimed at extending the lives of advanced state and recurrent patients. As a member of the Metastatic Cancer Task Force, CDMRP encourages applicants to review the recommendations (https://health.mil/Reference-Center/Congressional-Testimonies/2018/05/03/Metastatic-Cancer-Research) and submit research ideas to address these recommendations provided they are within the limitations of this funding opportunity and fit within the FY24 NFRP priorities.

**Rigorous Study Design:** All projects should adhere to a core set of standards for rigorous study design and reporting to maximize the reproducibility and translational potential of clinical and preclinical research. The standards are described in SC Landis et al., 2012, A call for transparent reporting to optimize the predictive value of preclinical research, *Nature* 490:187-191 (<u>http://www.nature.com/nature/journal/v490/n7419/full/nature11556.html</u>). While these standards are written for preclinical studies, the basic principles of randomization, blinding, sample-size estimation, and data handling derive from well-established best practices in clinical studies.

*Military Service Involvement:* Applications from investigators within the military services and applications involving multidisciplinary collaborations among academia, industry, the military services, the U.S. Department of Veterans Affairs (VA), and other federal government agencies are highly encouraged. These relationships can leverage knowledge, infrastructure, and access to unique clinical populations that the collaborators bring to the research effort, ultimately advancing research that is of significance to Service Members, Veterans, and/or their Families. If the proposed research relies on access to unique resources or databases, the application must describe the access at the time of submission and include a plan for maintaining access as needed throughout the proposed research.

*Clinical trials are not allowed under this funding opportunity. A clinical trial is defined* in the Code of Federal Regulations, Title 45, Part 46.102 (45 CFR 46.102) as a research study in which one or more human subjects are prospectively assigned to one or more interventions (which may include a placebo or another control) to evaluate the effects of the interventions on biomedical or behavioral health-related outcomes.

# Studies that do not seek to measure safety, effectiveness, and/or efficacy outcome(s) of an intervention are not considered clinical trials.

For the purposes of this funding opportunity, research that meets the definition of a clinical trial is distinct from clinical research. Clinical research encompasses research with human data, human specimens, and/or interaction with human subjects. Clinical research is observational in nature and includes:

(1) Research conducted with human subjects and/or material of human origin such as data, specimens, and cognitive phenomena for which an investigator (or co-investigator) does *not* seek to assess the safety, effectiveness, and/or efficacy outcomes of an intervention. Research

meeting this definition may include but is not limited to: (a) mechanisms of human disease, (b) diagnostic or detection studies (e.g., biomarker or imaging), (c) health disparity studies, and (d) development of new technologies.

(2) Epidemiologic and behavioral studies that do *not* seek to assess the safety, effectiveness, and/or efficacy outcomes of an intervention.

(3) Outcomes research and health services research that do not fit under the definition of clinical trial.

Excluded from the definition of clinical research are in vitro studies that utilize human data or specimens that cannot be linked to a living individual and meet the requirements for exemption under  $\frac{46.104(d)(4)}{1000}$  of the Common Rule.

**Research Involving Animals:** All research funded by the FY24 NFRP Exploration-Hypothesis Development Award involving new and ongoing research with animals must be reviewed and approved by the USAMRDC Office of Human and Animal Research Oversight (OHARO) Animal Care and Use Review Office (ACURO), in addition to the local Institutional Animal Care and Use Committee (IACUC) of record. IACUC approval at the time of submission is *not* required. *Allow at least 3 to 4 months for ACURO regulatory review and approval processes for animal studies.* Refer to the General Application Instructions, Appendix 1, for additional information.

The funding instrument for awards made under the program announcement will be grants (31 USC 6304).

The anticipated direct costs budgeted for the entire period of performance for an FY24 NFRP New Investigator should not exceed **\$450,000**. Refer to <u>Section II.D.5, Funding Restrictions</u>, for detailed funding information.

Awards supported with FY24 funds will be made no later than September 30, 2025.

The CDMRP expects to allot approximately \$2.88M to fund approximately four New Investigator Award applications. Funding of applications received is contingent upon the availability of federal funds for this program, the number of applications received, the quality and merit of the applications as evaluated by peer and programmatic review, and the requirements of the government. Funds to be obligated on any award resulting from this funding opportunity will be available for use for a limited time period based on the fiscal year of the funds. It is anticipated that awards made from this FY24 funding opportunity will be funded with FY24 funds, which will expire for use on September 30, 2030.

# **II.C. Eligibility Information**

#### **II.C.1. Eligible Applicants**

**II.C.1.a. Organization:** Extramural and Intramural organizations are eligible to apply, including foreign or domestic organizations, for-profit and non-profit organizations, and public entities.

**Extramural Organization:** An eligible non-Department of Defense (DOD) organization. Examples of extramural organizations include academic institutions, biotechnology companies, foundations, federal government organizations other than the DOD (i.e., intragovernmental organizations), and research institutes.

**Intramural DOD Organization:** Refers specifically to DOD organizations including DOD laboratories, DOD military treatment facilities, and/or DOD activities embedded within a civilian medical center.

Awards are made to eligible *organizations*, not to individuals. Refer to the General Application Instructions, Appendix 1, for additional recipient qualification requirements

#### II.C.1.b. Principal Investigator

# Graduate students, postdoctoral fellows, and other "mentored" researchers are not eligible for this award.

- PIs must be either an Early-Stage Investigator or an Established Investigator, as described below.
  - Early-Stage Investigator
    - An investigator *at or below* the level of Assistant Professor (or equivalent) at time of submission.
    - Investigators must commit at least 30% during each budget year of their efforts toward the proposed NF research project. Changes in level of effort after the first year will be evaluated on a case-by-case basis and at the discretion of the Grants Officer, but PIs must maintain a 30% dedication of their full-time efforts during the award period to NF research.
    - Experience in NF research is not required; however, applications must focus on NF, and the PIs must maintain a 30% dedication of their full-time efforts during the award period to NF.

or

#### • Established Investigator

- Established investigators in <u>an area other than NF</u> at or above the level of Assistant Professor <u>seeking to transition to a career in NF</u>, thereby bringing their expertise to the field.
- Investigators must commit at least 10% during each budget year of their efforts toward the proposed NF research project.
- PIs must not have received more than \$300,000 in total direct costs for previous NF research as a PI of one or more federally funded, non-mentored peer reviewed grants <u>at the time of application submission</u>.
- PIs must not have received a New Investigator Award previously from any program within the CDMRP.

An eligible PI, regardless of ethnicity, nationality, or citizenship status, must be employed by or affiliated with an eligible organization.

#### **II.C.2.** Cost Sharing

Cost sharing/matching is not an eligibility requirement.

#### II.C.3. Other

Organizations must be able to access **.gov** and **.mil** websites to fulfill the financial and technical deliverable requirements of the award and submit invoices for payment.

Refer to <u>Section II.H.2</u>, <u>Administrative Actions</u>, for a list of administrative actions that may be taken if a pre-application or full application does not meet the administrative, eligibility, or ethical requirements defined in this program announcement.

### **II.D.** Application and Submission Information

#### **II.D.1.** Location of Application Package


Submission is a two-step process requiring both a *pre-application* submitted via the Electronic Biomedical Research Application Portal (eBRAP.org) and a *full application* (eBRAP.org or Grants.gov). Depending on the type of submission (i.e., extramural vs. intramural), certain aspects of the submission process will differ.

The CDMRP uses two portal systems to accept pre- and full application submissions.

**eBRAP** (<u>https://ebrap.org</u>) is a secure web-based system that allows PIs and/or organizational representatives from both extra- and intramural organizations to receive communications from the CDMRP and submit their pre-applications. Additionally, eBRAP allows extramural applicants to view and verify full applications submitted to Grants.gov and allows intramural

DOD applicants to submit and verify full applications following their pre-application submission.

**Grants.gov** (<u>https://grants.gov</u>) is a federal system that must be used by funding agencies to announce extramural grant applications. Full applications for CDMRP funding opportunities can only be submitted to Grants.gov after submission of a pre-application through eBRAP.



#### Application Submission Workflow

**Extramural Submission:** An application submitted by an <u>extramural organization</u> for an extramural or intramural PI working within an extramural or intramural organization. For example, a research foundation submitting an application for a DOD employee working within a DOD organization would be considered an extramural submission and should follow instructions specific to extramural submissions. Download application package components for HT942524NFRPNIA from Grants.gov (<u>https://grants.gov</u>). Full applications from extramural organizations *must* be submitted through Grants.gov.

**Intramural Submission:** An application submitted by an <u>intramural DOD organization</u> for an investigator employed by that organization. Intramural DOD organizations <u>may</u> submit full applications to either eBRAP or Grants.gov. Download application package components for HT942524NFRPNIA from the anticipated submission portal eBRAP (<u>https://ebrap.org</u>) or Grants.gov.

The submission process should be started early to avoid missing deadlines. Regardless of submission type or portal used, all pre- and full application components must be submitted by the deadlines stipulated on the first page of this program announcement. There are no grace periods for deadlines; failure to meet submission deadlines will result in application rejection. *The* **USAMRAA cannot make allowances/exceptions for submission problems encountered by the applicant organization using system-to-system interfaces with Grants.gov.** 

#### **II.D.2.** Content and Form of the Application Submission

# Submitting applications that propose essentially the same research project to different funding opportunities within the same program and fiscal year is prohibited and will result in administrative withdrawal of the duplicative application(s).

Unnecessary duplication of funding or accepting funding from more than one source for the same research is prohibited. See the CDMRP's full position on research duplication at <a href="https://cdmrp.health.mil/funding/researchDup">https://cdmrp.health.mil/funding/researchDup</a>.

Including classified research data within the application and/or proposing research that may produce classified outcomes, or outcomes deemed sensitive to national security concerns, may result in application withdrawal. Refer to the General Application Instructions, Appendix 7, Section B.

FY24 NFRP Programmatic Panel members should not be involved in any pre-application or full application. For questions related to panel members and pre-applications or applications, refer to <u>Section II.H.2.c</u>, <u>Withdrawal</u>, or contact the eBRAP Help Desk at <u>help@eBRAP.org</u> or 301-682-5507.

#### II.D.2.a. Step 1: Pre-Application Submission

All pre-application components must be submitted by the Initiating PI through eBRAP (<u>https://eBRAP.org/</u>), including the submission of contact information for each Partnering PI.

During the pre-application process, eBRAP assigns each submission a unique log number. This unique log number is required during the full application submission process. The eBRAP log number, application title, and all information for each PI, the Business Official(s), performing organization(s), and contracting organization(s) must be consistent throughout the entire pre-application and full application submission process. Inconsistencies may delay application processing and limit or negate the ability to view, modify, and verify the application in eBRAP. If any changes need to be made, the applicant should contact the eBRAP Help Desk at help@eBRAP.org or 301-682-5507 prior to the application submission deadline.

When starting the pre-application, applicants will be asked to select a "Mechanism Option". Please be sure to select the correct option appropriate to your pre-application:

#### II.D.2.a.i. Pre-Application Components

Pre-application submissions must include the following components (refer to the General Application Instructions, Section III.B, for detailed instructions regarding pre-application submission):

• Letter of Intent (LOI) (one-page limit): Provide a brief description of the research to be conducted.

LOIs are used for program planning purposes only (e.g., reviewer recruitment) and will not be reviewed during either the peer or programmatic review. *An invitation to submit a full application is NOT provided after LOI submission. Applicants are encouraged to develop pre-application and full application components concurrently and submit a full application AFTER successful submission of the pre-application.* 

#### II.D.2.b. Step 2: Full Application Submission

#### II.D.2.b.i. Full Application Submission Type

**Extramural Submissions:** Full applications from extramural organizations *must* be submitted through Grants.gov Workspace. Full applications from extramural organizations, including non-DOD federal organizations, received through eBRAP will be withdrawn. Refer to the General Application Instructions, Section IV, for considerations and detailed instructions regarding extramural full application submission.

**Intramural Submissions:** Intramural DOD organizations may submit full applications through either eBRAP or Grants.gov. There is no preference from the CDMRP for which submission portal is utilized; submission through one portal or the other does not provide the application any advantage during the review process. Intramural DOD organizations that choose to submit through Grants.gov should follow Extramural Submission instructions. Intramural DOD organizations that are unable to submit through Grants.gov should submit through eBRAP. For the remainder of this program announcement, it will be assumed intramural DOD submissions will proceed through eBRAP. Refer to the General Application Instructions, Section V, for considerations and detailed instructions regarding intramural DOD full application submission.

#### II.D.2.b.ii. Full Application Submission Components

Each application submission must include the completed full application package for this program announcement. See <u>Section II.H.3</u> of this program announcement for a checklist of the required application components.

(a) SF424 Research & Related Application for Federal Assistance Form *(Extramural Submissions Only)*: Refer to the General Application Instructions, Section IV.B, for detailed information.

#### (b) Attachments:

Each attachment to the full application components must be uploaded as an individual file in the format specified and in accordance with the formatting guidelines listed in the General Application Instructions, Appendix 2.

• Attachment 1: Project Narrative (10-page limit): Upload as "ProjectNarrative.pdf". The page limit of the Project Narrative applies to text and nontext elements (e.g., figures, tables, graphs, photographs, diagrams, chemical structures, drawings) used to describe the project. Inclusion of URLs (uniform resource locators) that provide additional information that expands the Project Narrative and could confer an unfair competitive advantage is prohibited and may result in administrative withdrawal of the application.

Describe the proposed project in detail using the outline below.

- **Background:** Clearly articulate the scientific rationale for the proposed research project. Cite relevant literature. *Applications must include preliminary and/or published data that are relevant to NF and the proposed research project.*
- Hypothesis: State the hypothesis to be tested or the objective to be reached.
- **Specific Aims:** Concisely explain the proposed research project's specific aims to be funded by this application. If the proposed research project is part of a larger study, present only tasks that this award would fund.

#### - Research Strategy and Feasibility:

- Describe how the experimental design, methods, and analyses, including appropriate controls, sample size estimations, blinding, randomization, power analysis, and data handling are designed to achieve reproducible and rigorous results in sufficient detail for scientific peer review. Address potential problem areas and present alternative methods and approaches. *Include specific examples of synergistic elements incorporated into the research design.*
- Describe the statistical plan for the research proposed, as appropriate.
- Describe how well any animal studies proposed are designed to achieve the objectives, including the choice of model and endpoints/outcome measures to be used.
- If human subjects or human anatomical samples will be used, include a detailed plan for the recruitment of subjects or the acquisition of samples. Clearly describe the tissue or tumor type to be studied, where applicable (e.g., encapsulated versus diffuse plexiform neurofibroma).
- If applicable, describe the strategy for the inclusion of women and minorities appropriate to the objectives of the study, including a description of the composition of the proposed study population in terms of sex/gender, racial, and ethnic group, and an accompanying rationale for the selection of subjects. Studies utilizing human biospecimens or datasets that cannot be linked to a specific individual, gender, ethnicity, or race (typically classified as exempt from Institutional Review Board (IRB) review) are exempt from this requirement. Additional reporting information is included in Attachment 2 below.
- If the proposed research involves access to active-duty military and/or U.S.
   Department of Veterans Affairs (VA) patient populations and/or DOD or VA

resources or databases, describe the access at the time of submission and include a plan for maintaining access as needed throughout the proposed research. Refer to the General Application Instructions, Appendix 4, for additional considerations.

• Attachment 2: Supporting Documentation: Combine and upload as a single file named "Support.pdf". Start each document on a new page. The Supporting Documentation attachment should not include additional information such as figures, tables, graphs, photographs, diagrams, chemical structures, or drawings. These items should be included in the Project Narrative.

There are no page limits for any of these components unless otherwise noted. Include only those components described below; inclusion of items not requested or viewed as an extension of the Project Narrative will result in the removal of those items or may result in administrative withdrawal of the application.

- **References Cited:** List the references cited (including URLs, if available) in the Project Narrative using a standard reference format.
- List of Abbreviations, Acronyms, and Symbols: Provide a list of abbreviations, acronyms, and symbols.
- Facilities, Existing Equipment, and Other Resources: Describe the facilities and equipment available for performance of the proposed project and any additional facilities or equipment proposed for acquisition at no cost to the award. Indicate whether government-furnished facilities or equipment are proposed for use. If so, reference should be made to the original or present government award under which the facilities or equipment items are now accountable. There is no form for this information.
- Publications and/or Patents: Include a list of relevant publication URLs and/or patent abstracts. If articles are not publicly available, then copies of up to five published manuscripts may be included in Attachment 2. Extra items will not be reviewed.
- Letters of Organizational Support: Provide a letter (or letters, if applicable) signed by the Department Chair or appropriate organization official, confirming the laboratory space, equipment, and other resources available for the project. Letters of support not requested in the program announcement, such as those from members of Congress, do not impact application review or funding decisions.
- Letters of Collaboration (*if applicable*): Provide a signed letter from each collaborating individual and/or organization demonstrating that the PI has the support and resources necessary for the proposed work. If an investigator at an intramural DOD organization is named as a collaborator on a full application submitted through an extramural organization, the application must include a letter from the collaborator's Commander or Commanding Officer at the intramural DOD organization authorizing the collaborator's involvement.

- Intellectual Property: Information can be found in the 2 CFR 200.315, "Intangible Property."
  - Intellectual and Material Property Plan *(if applicable)*: Provide a plan for resolving intellectual and material property issues among participating organizations.
  - **Commercialization Strategy** *(if applicable)*: Describe the commercialization plan. The plan should include intellectual property, market size, financial analysis, strengths and weaknesses, barriers to the market, competitors, and management team. Discuss the significance of this development effort, when it can be anticipated, and the potential commercial use for the technology being developed.
- DOD Data Management Plan: Describe the data management plan in accordance with Section 3.c, Enclosure 3, <u>DoD Instructions 3200.12</u>. Do not duplicate the Data and Research Resources Sharing Plan. Refer to General Application Instructions, Section IV.B, Attachments Form, Attachment: Supporting Documentation, for detailed information regarding Data Management Plan content.
- Inclusion Enrollment Plan (only required if clinical research is proposed): Provide an anticipated enrollment table(s) for the inclusion of women and minorities using the Public Health Service (PHS) Inclusion Enrollment Report, a three-page fillable PDF form, that can be downloaded from eBRAP at <a href="https://ebrap.org/eBRAP/public/">https://ebrap.org/eBRAP/public/</a> Program.htm. The enrollment table(s) should be appropriate to the objectives of the study with the proposed enrollment distributed on the basis of sex/gender, race, and ethnicity. Studies utilizing human biospecimens or datasets that cannot be linked to a specific individual, gender, ethnicity, or race (typically classified as exempt from IRB review) are exempt from this requirement.
- Use of DOD Resources *(if applicable)*: Provide a letter of support signed by the lowest-ranking person with approval authority confirming access to active-duty military populations and/or DOD resources or databases.
- Use of VA Resources (*if applicable*): Provide a letter of support signed by the VA Facility Director(s) or individual designated by the VA Facility Director(s), such as the Associate Chief of Staff for Research and Development (ACOS/R&D) or Clinical Service Chief, confirming access to VA patients, resources, and/or VA research space. If the VA-affiliated non-profit corporation is not identified as the applicant organization for administering the funds, include a letter from the VA ACOS/R&D confirming this arrangement and identifying the institution that will administer the funds associated with the proposed research.
- Attachment 3: Technical Abstract (one-page limit): Upload as "TechAbs.pdf". The technical abstract is used by all reviewers. *Abstracts of all funded research projects will be posted publicly.* Use only characters available on a standard QWERTY keyboard.

Spell out all Greek letters, other non-English letters, and symbols. Graphics are not allowed.

Technical abstracts should be written using the outline below. Clarity and completeness within the space limits are highly important.

- **Background:** Present the scientific rationale behind the proposed research project.
- **Hypothesis/Objective(s):** State the hypothesis to be tested and/or objective(s) to be reached.
- **Specific Aims:** State the specific aims of the study.
- **Study Design:** Describe the study design, including appropriate controls.
- **Innovation:** Briefly describe how the proposed research project is innovative in the field of NF
- **Impact:** Briefly describe how the proposed research project will have short-term and/or long-term impact on NF research and/or patient care.
- Attachment 4: Lay Abstract (one-page limit): Upload as "LayAbs.pdf". The lay abstract is used by all reviewers, and addresses issues of particular interest to the affected community. *Abstracts of all funded research projects will be posted publicly.* Use only characters available on a standard QWERTY keyboard. Spell out all Greek letters, other non-English letters, and symbols. Graphics are not allowed. *Do not duplicate the technical abstract.*

Lay abstracts should address the points outlined below *in a manner that will be readily understood by readers without a background in science or medicine*. Avoid overuse use of scientific jargon, acronyms, and abbreviations.

- Summarize the objectives and rationale for the proposed research.
- Describe the ultimate applicability of the research.
  - What population will the research help, and how will it help them?
  - What are the potential applications, benefits, and risks of the anticipated outcomes?
  - What is the projected time it may take to achieve a patient-related outcome?
  - What are the likely contributions of the proposed research project to advancing research, patient care, and/or quality of life?
  - How will the data and resources generated during the performance of the proposed research project be shared with the research community (scientific and advocacy organizations) and the public?

 Attachment 5: Statement of Work (three-page limit): Upload as "SOW.pdf". Refer to the eBRAP "Funding Opportunities & Forms" web page (<u>https://ebrap.org/eBRAP/public/Program.htm</u>) for the suggested Statement of Work (SOW) format and recommended strategies for assembling the SOW.

For the New Investigator Award, refer to "Example: Assembling a Generic Statement of Work", for guidance on preparing the SOW. Use the "Suggested SOW Format" to develop the SOW for the proposed research. Submit as a PDF.

- Attachment 6: Impact Statement (one-page limit): Upload as "Impact.pdf". Explain how the proposed research project addresses one or more of the <u>FY24 NFRP</u> <u>Areas of Emphasis</u> or, if the project does not address an Area of Emphasis, provide justification that the proposed research project addresses a critical problem in NF research and/or patient care. Detail the anticipated outcome(s) that will be directly attributed to the results of the proposed research (short-term gains). Explain the anticipated long-term gains from the proposed research project, including how the new understanding may ultimately contribute to the goal of advancing NF research and/or patient care. Describe how the data and resources generated during the performance of the proposed research project will be shared with the research community (scientific and advocacy organizations) and the public.
- Attachment 7: Innovation Statement (one-page limit): Upload as "Innovation.pdf". Describe how the proposed research project is innovative in the field of NF. Research deemed innovative may represent a novel paradigm, challenge current paradigms, examine existing problems from novel perspectives, or exhibit other highly creative qualities. Innovative research may include high-risk approaches. Research that is an incremental advance upon published data is not considered innovative.

*Although not all-inclusive*, the following examples are ways in which the proposed research project may be innovative:

- Explores a novel idea and/or research question in NF supported by relevant preliminary data.
- Uses or develops novel methods or technologies to address a question in NF.
- Applies or adapts existing methods or technologies for novel NF research or clinical purposes that differ fundamentally from those originally intended.
- Attachment 8: Eligibility Statement (one-page limit) (only applicable to the Early-Stage Investigator option): Upload as "Eligibility.pdf". Provide a letter, signed by the PI and the Department Chair, Dean, or equivalent official, to verify that the eligibility requirements for an Early-Stage Investigator have been met by the application submission deadline. The letter should provide the date (month/year) the PI completed/will complete requirements for their doctoral degree, and the date (month/year) the PI began/will begin postdoctoral research in the proposed setting. Refer to Section II.C, Eligibility Information, of the program announcement for requirements.

- Attachment 9: Career Plan (one-page limit): Upload as "Career.pdf". Describe the PI's plan for continued development as an NF researcher (Early-Stage Investigator) and/or the transition into a career in the field of NF research (Established Investigator).
- Attachment 10: Animal Research Plan (three-page limit) (required if the proposed research project involves animals; failure to provide this plan may negatively impact the review): Upload as "AnimalResPlan.pdf".

If the proposed study involves animals, a summary describing the animal research that will be conducted must be included in the application. Consult the ARRIVE guidelines 2.0 (Animal Research: Reporting *In Vivo* Experiments) to ensure relevant aspects of rigorous animal research are adequately planned for and, ultimately, reported. The ARRIVE guidelines 2.0 can be found at <a href="https://arriveguidelines.org/arrive-guidelines">https://arriveguidelines.org/arrive-guidelines</a>. The Animal Research Plan may not be an exact replica of the protocol(s) submitted to the IACUC. The Animal Research Plan should address the following points to achieve reproducible and rigorous results for each proposed animal study:

- Briefly describe the research objective(s) of the animal study. Explain how and why the animal species, strain, and model(s) being used can address the scientific objectives and, where appropriate, the study's relevance to human biology.
- Summarize the procedures to be conducted. Describe how the study will be controlled.
- Describe the randomization and blinding procedures for the study and any other measures to be taken to minimize the effects of subjective bias during animal treatment and assessment of results. If randomization and/or blinding will not be utilized, provide justification.
- Provide a sample size estimate for each study arm and the method by which it was derived, including power analysis calculations.
- Describe how data will be handled, including rules for stopping data collection, criteria for inclusion and exclusion of data, how outliers will be defined and handled, statistical methods for data analysis, and identification of the primary endpoint(s)/outcome(s).
- Attachment 11: Data and Research Resources Sharing Plan (two-page limit): Upload as "DataResourceSharing.pdf". Describe how data and resources generated during the performance of the proposed research project will be shared with the research community. If developing resources is part of the proposed research project, including animal models, tissue samples, methods, or other resources, specifically describe how the scientific community can obtain these resources. Refer to the General Application Instructions, Appendix 2, Section K, for more information about the CDMRP's expectations for making data and research resources publicly available. *Refer to the NFRP Research Resources Initiative paragraph at the end of Section II.A.1, FY23 NFRP Areas of Emphasis.*

If an intramural DOD organization will be a collaborator in performance of the project, complete a separate budget using the "Suggested Intragovernmental/Intramural Budget Form", available for download on the eBRAP "Funding Opportunities & Forms" web page (<u>https://ebrap.org/eBRAP/public/Program.htm</u>). The budget should cover the entire period of performance for each intramural DOD site and include a budget justification as instructed. The *total* costs per year for each subaward (direct and indirect costs) should be included on the Grants.gov Research & Related Budget Form under subaward costs. The NIH Biographical Sketch may also be used. All biographical sketches should be submitted in uneditable PDF format.
  - **PI Previous/Current/Pending Support (no page limit):** Upload as "Support\_LastName.pdf".
  - **Key Personnel Biographical Sketches (five-page limit each):** Upload as "Biosketch\_LastName.pdf".
  - **Key Personnel Previous/Current/Pending Support (no page limit):** Upload as "Support\_LastName.pdf".

- (e) Research & Related Budget: For extramural submissions, refer to the General Application Instructions, Section IV.B.(e), and for intramural submissions, refer to the General Application Instructions, Section V.A.(e), for detailed instructions.
  - Budget Justification (no page limit): For extramural submissions, refer to the General Application Instructions, Section IV.B.(e), Section L, for instructions. For intramural submissions, refer to General Application Instructions, Section V.A.(e), Budget Justification Instructions.
- (f) Project/Performance Site Location(s) Form: For extramural submissions, refer to the General Application Instructions, Section IV.B.(f), and for intramural submissions, refer to the General Application Instructions, Section V.A.(f), for detailed instructions.
- (g) Research & Related Subaward Budget Attachment(s) Form *(if applicable, Extramural Submissions Only)*: Refer to the General Application Instructions, Section IV.B.(g), for detailed instructions.
  - **Extramural Subaward:** Complete the Research & Related Subaward Budget Form and upload through Grants.gov.

#### II.D.2.c. Applicant Verification of Full Application Submission in eBRAP

Independent of submission type, once the full application is submitted it is transmitted to and processed in eBRAP. At this stage, the PI and organizational representatives will receive an email from eBRAP instructing them to log into eBRAP to review, modify, and verify the full application submission. Verification is strongly recommended but not required. eBRAP will validate full application files against the specific program announcement requirements, and discrepancies will be noted in the "Full Application Files" tab in eBRAP. However, eBRAP does not confirm the accuracy of file content. It is the applicant's responsibility to review all application components and ensure proper ordering as specified in the program announcement. *The Project Narrative and Research & Related Budget Form cannot be changed after the application submission deadline. If either the Project Narrative or the budget fails eBRAP validation or needs to be modified, an updated full application package must be submitted prior to the full application submission deadline.* Other application components, including subaward budget(s) and subaward budget justification(s), may be changed until the end of the application period ends.

#### II.D.3. Unique Entity Identifier (UEI) and System for Award Management (SAM)

The applicant organization must be registered as an entity in SAM (<u>https://www.sam.gov/content/home</u>) and receive confirmation of an "Active" status before submitting an application through Grants.gov. Organizations must include the UEI generated by SAM in applications to this funding opportunity.

#### **II.D.4.** Submission Dates and Times

The pre-application and application submission process should be started early to avoid missing deadlines. There are no grace periods. Failure to meet either of these deadlines will result in submission rejection.

All submission dates and times are indicated in Section I, Overview of the Funding Opportunity.

#### **II.D.5.** Funding Restrictions

The maximum period of performance is 3 years.

The application's direct costs budgeted for the entire period of performance should not exceed **\$450,000**. If indirect cost rates have been negotiated, indirect costs are to be budgeted in accordance with the organization's negotiated rate. Collaborating organizations should budget associated indirect costs in accordance with each organization's negotiated rate.

All direct and indirect costs of any subaward or contract must be included in the direct costs of the primary award.

The applicant may request the entire maximum funding amount for a project that may have a period of performance less than the maximum 3 years.

For this award mechanism, direct costs may be requested for (not all-inclusive):

- Travel in support of multi-institutional collaborations.
- Costs for one investigator to travel to one scientific/technical meeting per year. The intent of travel to scientific/technical meetings should be to present project information or disseminate project results from the NFRP New Investigator Award.

Must not be requested for:

• Clinical trial costs

#### **II.D.6.** Other Submission Requirements

#### **II.E.** Application Review Information

#### II.E.1. Criteria

#### II.E.1.a. Peer Review

To determine technical merit, all applications will be individually evaluated according to the following **scored criteria**, which are listed in **decreasing order of importance:** 

#### • Personnel

- To what degree the PI's experience, level of expertise, and record of accomplishment demonstrate their ability to successfully complete the proposed research project.
- How well the application describes the PI's understanding of NF and clearly articulates the studies to be conducted.
- The PI's potential for contributing to the NF research field based on their background and experience.
  - For Early-Stage Investigators, to what extent the PI has a potential for developing a promising career in the field of NF research.
  - For Established Investigators, to what extent the PI will bring their expertise to the field of NF and pursue an active line of research in NF.
- To what extent the levels of effort by the PI (minimum of 30% for Early-Stage Investigators and 10% for Established Investigators per budget year) and other key personnel are appropriate to ensure success of the proposed research project.

#### • Research Strategy and Feasibility

- How well the preliminary data and scientific rationale support the proposed research project.
- How well the study (or studies) is designed to achieve reproducible and rigorous results, including controls, sample size estimation, blinding, randomization, power analysis, and data handling.
- How well any animal studies proposed are designed to achieve the objectives, including the choice of model and endpoints/outcome measures to be used.
- To what extent the proposed research project is feasible as described.
- How well the application identifies potential problems and addresses alternative approaches.
- If applicable, whether the strategy for the inclusion of women and minorities and distribution of proposed enrollment is appropriate for the proposed research.
- If applicable, to what degree the intellectual and material property plan is appropriate.

#### • Impact

- To what extent:
  - The anticipated outcomes (short-term gains) will be used as the foundation for future research projects.

- The anticipated long-term gains will contribute to the goal of advancing NF research and/or patient care.
- The data and resources generated during the performance of the proposed research project will be shared with the research community (scientific and advocacy organizations) and the public.
- How well the proposed research project addresses one or more of the <u>FY24 NFRP Areas</u> of <u>Emphasis</u> or a critical problem in NF research and/or patient care.

#### • Innovation

- To what extent the proposed research project is innovative to the field of NF in one or more of the following ways: research concept or question, development of novel research methods or technologies, adaptations of existing methods or technologies, or other innovations.
- To what extent the proposed research project represents more than an incremental advance upon published data and/or may be considered high-risk.

In addition, the following criteria will also contribute to the overall evaluation of the application, but will not be individually scored and are therefore termed **unscored criteria**:

#### • Data and Resource Sharing

- How well the Data and Research Resource Sharing Plan is detailed, including but not limited to:
  - The description of the type of data or research resource(s) to be made publicly available
  - How well the plan for access to data or research resources is detailed
  - The appropriateness of plans to ensure the data or research resource(s) is/are accessible after the period of performance expires
  - The appropriateness of the milestones with respect to making the data or research resource(s) available.
  - How well the data in the application follows the Data Principles for reproducible science found in "<u>The FAIR Guiding Principles for scientific data management and</u> <u>stewardship</u>."

#### • Budget

- Whether the **direct costs** exceed the allowable direct costs as published in the program announcement
- Whether the budget is appropriate for the proposed research

#### • Environment

- To what extent the scientific environment is appropriate for the proposed research project.
- How well the research requirements are supported by the availability of and accessibility to facilities and resources.
- To what extent the quality and level of institutional support are appropriate for the proposed research project.
- Application Presentation
  - To what extent the writing, clarity, and presentation of the application components influence the review.

#### II.E.1.b. Programmatic Review

To make funding recommendations and select the application(s) that, individually or collectively, will best achieve the program objectives, the following criteria are used by programmatic reviewers:

- Ratings and evaluations of the peer reviewers
- Relevance to the priorities of the Defense Health Program and FY24 NFRP, as evidenced by the following:
  - Adherence to the intent of the funding opportunity
  - Program portfolio composition
  - Relative impact and innovation and/or military benefit
  - Programmatic relevance to the <u>FY24 NFRP Areas of Emphasis</u>

#### **II.E.2.** Application Review and Selection Process

All applications are evaluated by scientists, clinicians, and consumers in a two-tier review process. The first tier is **peer review**, the evaluation of applications against established criteria to determine technical merit, where each application is assessed for its own merit, independent of other applications. The second tier is **programmatic review**, a comparison-based process in which applications with high scientific and technical merit are further evaluated for programmatic relevance. Final recommendations for funding are made to the Commanding General, USAMRDC. *The highest-scoring applications from the first tier of review are not automatically recommended for funding*. *Funding recommendations depend on various factors as described in <u>Section II.E.1.b, Programmatic Review</u>. Additional information about the two-tier process used by the CDMRP can be found at <a href="https://cdmrp.health.mil/about/2tierRevProcess">https://cdmrp.health.mil/about/2tierRevProcess</a>.* 

All CDMRP review processes are conducted confidentially to maintain the integrity of the meritbased selection process. Panel members sign a statement declaring that application and evaluation information will not be disclosed outside the review panel. Violations of confidentiality can result in the dissolution of a panel(s) and other corrective actions. In addition, personnel at the applicant or collaborating organizations are prohibited from contacting persons involved in the review and approval process to gain protected evaluation information or to influence the evaluation process. Violations of these prohibitions will result in the administrative withdrawal of the organization's application. Violations by panel members or applicants that compromise the confidentiality of the review and approval process may also result in suspension or debarment from federal awards. Furthermore, the unauthorized disclosure of confidential information of one party to a third party is a crime in accordance with 18 USC 1905.

#### **II.E.3. Integrity and Performance Information**

Prior to making an assistance agreement award where the federal share is expected to exceed the simplified acquisition threshold, as defined in 2 CFR 200.1, over the period of performance, the federal awarding agency is required to review and consider any information about the applicant that is available in SAM.

An applicant organization may review SAM and submit comments on any information currently available about the organization that a federal awarding agency previously entered. The federal awarding agency will consider any comments by the applicant, in addition to other information in the designated integrity and performance system, in making a judgment about the applicant's integrity, business ethics, and record of performance under federal awards when determining a recipient's qualification prior to award, according to the qualification standards of the Department of Defense Grant and Agreement Regulations (DoDGARs), Section 22.415.

# **II.F. Federal Award Administration Information**

#### **II.F.1. Federal Award Notices**

Each applicant organization and PI will receive email notification when the funding recommendations are posted to eBRAP. At this time, each PI will receive a peer review summary statement on the strengths and weaknesses of the application and an information paper describing the funding recommendation and review process for the NFRP award mechanisms. The information papers and a list of organizations and PIs recommended for funding are also posted on the program's page within the CDMRP website.

If an application is recommended for funding, after the email notification is posted to eBRAP, a government representative will contact the person authorized to negotiate on behalf of the recipient organization.

Only an appointed USAMRAA Grants Officer may obligate the government to the expenditure of funds to an extramural organization. No commitment on the part of the government should be inferred from discussions with any other individual. The award document signed by the Grants Officer is the official authorizing document (i.e., assistance agreement).

#### Intra-DOD obligations of funding will be made according to the terms of a negotiated Inter-Agency Agreement and managed by a CDMRP Science Officer.

Funding obligated to *intragovernmental and intramural DOD organizations* will be sent through the Military Interdepartmental Purchase Request (MIPR), Funding Authorization Document (FAD), or Direct Charge Work Breakdown Structure processes. Transfer of funds is contingent upon appropriate safety and administrative approvals. Intragovernmental and intramural DOD investigators and collaborators must coordinate receipt and commitment of funds through their respective Resource Manager/Task Area Manager/Comptroller or equivalent Business Official.

An organization may, at its own risk and without the government's prior approval, incur obligations and expenditures to cover costs up to 90 days before the beginning date of the initial budget period of a new award. For extramural submissions, refer to the General Application Instructions, Section IV.B.(e), Pre-Award Costs section, and for intramural submissions, refer to the General Application Instructions, Section V.A.(e), Pre-Award Costs section, for additional information about pre-award costs.

If there are technical reporting requirement delinquencies for any existing CDMRP awards at the applicant organization, no new awards will be issued to the applicant organization until all delinquent reports have been submitted.

#### **II.F.2. PI Changes and Award Transfers**

Changes in PI are not allowed, except under extenuating circumstances that will be evaluated on a case-by-case basis.

An organizational transfer of an award will not be allowed in the last year of the (original) period of performance or any extension thereof.

Refer to the General Application Instructions, Appendix 7, Section F, for general information on organization or PI changes.

#### **II.F.3.** Administrative and National Policy Requirements

Applicable requirements in the DoDGARs found in 32 CFR, Chapter I, Subchapter C, and 2 CFR, Chapter XI, apply to grants and cooperative agreements resulting from this program announcement.
