<p><b>Career Development Award</b></p> <p>Go to:</p> <ul style="list-style-type: none"> <li><a href="#">Program Announcement</a></li> <li><a href="#">General Application Instructions</a></li> </ul> <p>Grants.gov Funding Opportunity Number: <b><u>W81XWH-19-TBDRP-CDA</u></b></p>	<p><b>Principal Investigator (PI):</b> Early-career research scientist or physician scientist within 10 years of completing terminal degree (excluding time in residency or on family medical leave) at the time of submission, working to become independent investigators who exhibit a strong desire to pursue careers in tick-borne disease research; time spend at a postdoctoral fellow is <i>not</i> excluded</p> <p><b>Mentor:</b> Independent investigators at or above the level of Associate Professor (or equivalent); must have a proven funding and publication record in tick-borne disease research</p> <p><i>The PI and Mentor do not need to be located within the same organization.</i></p>	<ul style="list-style-type: none"> <li>To fund <b>early-career investigators</b> to conduct impactful research under the <b>mentorship</b> of an experienced tick-borne disease researcher.</li> <li><b>Career Development Plan is required.</b> Plan should be prepared with appropriate guidance from the Mentor, should clearly articulate a strategy for acquiring the necessary skills, competence, and expertise to establish a career at the forefront of tick-borne disease research, and should outline how the PI will gain experience in tick-borne disease research. PI's institution must demonstrate a commitment to the PI through a minimum of 75% protected time for tick-borne disease research.</li> <li>Preliminary data are not required; however, logical reasoning and a sound scientific rationale for the proposed research must be demonstrated.</li> <li><b>Clinical trials are not allowed.</b></li> </ul>	<ul style="list-style-type: none"> <li>Maximum funding of <b>\$250K</b> for direct costs (plus indirect costs).</li> <li>Maximum period of performance is <b>3</b> years.</li> </ul>	<p><b>Pre-Application (Letter of Intent):</b></p> <p>May 22, 2019 5:00 p.m. Eastern Time (ET)</p> <p><b>Application:</b></p> <p>August 22, 2019 11:59 p.m. ET</p>
